

COMMUNITY DENTAL CLINICS

Van Buren/Cass District Health Department's Community Dental Clinics provide quality dental care at an affordable price for adults and children. As fully functioning dental clinics with state of the art dental equipment, community members have access to an array of dental services including: preventive, restorative, prosthetic, and surgical services. Dental services are provided at three different office locations (Dowagiac, Hartford, Mattawan) with a total of 27 operatories.

MOBILE DENTAL OUTREACH PROGRAM

VBCDHD proudly delivers a mobile dental outreach program, providing screening and fluoride varnish, oral health education, and referrals to dental homes/restorative care to students preschool through 12th grade in Van Buren and Cass County schools. Through the Mobile Dental Outreach Program a Dental Hygienist and Dental Assistant travel to area schools to administer services on site, making it easy and convenient for children to get the preventive care and oral health education they need. Students receive dental kits (toothbrush, toothpaste, floss) and dental staff work with parents to set up care plans to ensure students with treatment needs—restorative and emergent—are linked to the care they need. Community mobile dental outreach also extends to community sites and adult programming.

EMERGENCY PREPAREDNESS

The Emergency preparedness program continues to update plans, policies and procedures per state and federal guidelines of the Public Health Emergency Preparedness Grant. During 2019, updated plans were submitted to the Bureau of EMS, Trauma and Preparedness. Partnerships with groups such as Van Buren and Cass County Local Emergency Planning Teams, schools, hospitals and other community programs continue to be a great benefit to the Health Department. The Emergency Preparedness Program continues to be an influential partner across the State of Michigan as it successfully completes all requirements of the Office of Public Health Preparedness. In 2019 our program focused on assisting our Environmental Health and Nursing Division with a variety of public health responses including EEE, PFAS and Hepatitis A as well as continued work on Whole Community Inclusion, infectious disease response, water contamination and mass medication distribution and dispensing campaigns.

FOOD SERVICE

VBCDHD's Food Service Program identifies food handling issues associated with the preparation, processing, and serving of food and beverages within our district. Food Service Environmental Health staff are responsible for: licensing and inspecting fixed mobile and transitory food establishments; issuing temporary permits to transient vendors that provide food at summer festivals and special events; performing plan reviews as an essential component to food establishment development and operator training; providing education and training opportunities to food service operators; tracking and reducing risks when food-related illnesses are reported.

NURSING

CHILDHOOD HEARING AND VISION SCREENING PROGRAM

VBCDHD Hearing and Vision Technicians provide objective hearing and vision screenings to children entering kindergarten through seventh grade. Vision screens are conducted once before entering kindergarten, in grades 1, 3, 5, 7 and in conjunction with driver's education or in 9th grade. Hearing screens are conducted once before entering kindergarten and in grades K, 2 and 4. All screenings are free of charge and offered in collaboration with Michigan grade schools and preschools including public, private, parochial, and charter. Parents are notified if their child fails a screening so they may seek medical intervention, diagnosis and treatment, and recommendations for care.

CHILDREN'S SPECIAL HEALTH CARE SERVICES (CSHCS) PROGRAM

The mission of the Children's Special Health Care Services* program is to enable individuals with special health care needs to have improved health outcomes and an enhanced quality of life. CSHCS nurses help families access specialty health care services by encouraging and facilitating parent involvement and collaboration with professionals, and working to remove barriers that interfere with access to and delivery of services and supports to meet clients' special health care needs. CSHCS serves individuals under 21 years of age, who have one or more of the 2,700+ medically qualifying conditions, including individuals 21 years and older with cystic fibrosis or hemophilia. The program helps pay for specialty medial care, transportation, co-pays and deductibles, and assists families with maintenance of private health care insurance. Families of all income levels are eligible. *CSHCS is provided in conjunction with the Michigan Department of Health and Human Services (MDHHS) and the federal government under Title V of the Social Security Act.

COMMUNICABLE DISEASE CONTROL

VBCDHD Communicable Disease Control program monitors and receives reports of all suspect and confirmed cases of communicable disease by area health providers, laboratories, schools, and daycare centers, including reports received from community members, as required by Michigan law. Utilizing the Michigan Disease Surveillance System, or by fax or phone to the Health Department, reports are made to trained VBCDHD Nursing Staff. Nursing staff are trained in disease investigation, treatment, case management, and contact follow up. Nurses educate partners and community members on transmission, prevention and intervention of communicable diseases and how to protect themselves, their families and the community. Local Public Health staff operate under protocols established by MDHHS according to Michigan Public Health Codes and Local Public Health policies and procedures.

IMMUNIZATION PROGRAM

Local immunization efforts serve to protect the public from epidemics or threatened epidemics of vaccine preventable diseases as well as protecting individuals from avoidable diseases and their complications. VBCDHD's Immunization Program is based on state immunization program guidelines and monitored for its' effectiveness, compliance with state program guidelines, and adherence to professional standards of practice as detailed by the Standards for Child and Adolescent Immunization and Standards for Adult Immunization Practices. VBCDHD maintains highly trained nursing staff responsible for providing immunization clinics for residents to dispense publicly funded vaccine; educating local school staff to ensure they understand school immunization requirements and accurately report student immunization status to MDHHS and the Michigan Department of Education; conducting site visits to local medical provider offices for quality assurance and compliance with the federal requirements of the Vaccines for Children (VFC) program; monitoring for fraud and abuse of publicly funded vaccine; and ensuring accessibility to vaccine, Improving local immunization rates, providing immunization, and developing private and public partnerships to promote high immunization coverage rates in the district.

SEXUALLY TRANSMITTED DISEASE PROGRAM

The goal of VBCDHD's STD/HIV program is to prevent the spread of sexually transmitted disease through clinical and educational services. STD/HIV Nurses provide counseling, testing, treatment and referrals, and facilitate individual and group education at schools, jails, substance abuse programs and other community sites. Partner services are offered to all infected individuals and STD/HIV nurses maintain ongoing communication with local medical providers to ensure appropriate treatment standards are upheld.

SPECIAL CYCLOSPORIASIS OUTBREAK REPORT

Cyclosporiasis Outbreak, Van Buren County, July 2019

Van Buren/Cass District Health Department received notification in July of 2019 via our Michigan Disease Surveillance System of two cases of Cyclosporiasis. As this investigation "unfolded" VBCDHD received a call from our State Epidemiologist reporting more cases of Cyclosporiasis in a nearby County that ate at the same location that was identified during our initial investigation of reported cases. At this point we classified this investigation as an official "outbreak." With collaboration among multiple agencies including Michigan Department of Health and Human Services, Michigan Department of Agriculture and Rural Development, local Hospital Labs, Providers, Public Health Nursing and Environmental Health Staff it was "all hands on deck." Multiple interviews were conducted using a specific questionnaire to help identify the "culprit" of this outbreak. In total there were 124 interviewed which included 96 ills and 27 wells. Multiple Counties and States were affected by this outbreak. The final count from this outbreak was 45 confirmed cases and 47 probable cases. 65% were females and 35% were males with an age range of 15-96 years of age. It was noted that there was a high probability that "Fresh Basil" was the "culprit" identified. The product had already been consumed and unfortunately washing the product doesn't always remove this parasite. Cyclosporiasis is a Reportable Disease in Michigan. This reportable pathogen is caused by a parasite called Cyclospora Cayetanensis. Cyclospora is spread by people ingesting the parasite through food or water that is contaminated with the parasite. The most common symptom of cyclosporiasis is watery diarrhea along with other symptoms including loss of appetite, weight loss, abdominal cramping, bloating, nausea, body aches and fatigue. There may also be vomiting and low grade fever.

Cyclosporiasis is found in many countries. The most common is in tropical and subtropical regions. In the U.S., foodborne outbreaks of cyclosporiasis have been linked to various types of imported fresh produce, including raspberries, basil, snow peas, and mesclun lettuce; no commercially frozen or canned produce has been implicated. Cyclospora typically takes at least 1-2 weeks after being passed in a bowel movement to become infectious to other people. Therefore, it is unlikely that Cyclospora are passed directly from one person to another. The best way to prevent cyclosporiasis is to avoid food or water that might be contaminated with stool. Follow safe fruit and vegetable handing recommendations: Wash hands with soap and warm water before and after handling or preparing fruits and vegetables. Wash cutting boards, dishes, utensils, and counter tops with soap and hot water between the preparation of raw meat, poultry, and seafood products and the preparation of fruits and vegetables that will not be cooked. Prepare all fruits and vegetables thoroughly under running water before eating, cutting, or cooking. Fruits and vegetables that are labeled "prewashed" do not need to be washed again at home. Scrub firm fruits and vegetables, such as melons and cucumbers, with a clean produce brush. Cut away any damaged or bruised areas on fruits and vegetables before preparing and eating. Storage- Refrigerate cut, peeled, or cooked fruits and vegetables as soon as possible, or within 2 hours. Store fruits and vegetables away from raw meat, poultry and seafood. 

Through community leadership and supporting other local efforts our department is focused on being a change maker and thought leader for our district. It is because of our collective impact efforts—the work of multiple organizations working together towards a common goal—that we recorded many successful initiatives in 2019. Of the accomplishments, a few notable include:

- Partnered with Bronson Healthcare Group to facilitate the Van Buren Community Health Needs Assessment
- Partnered with Ascension Borgess-Lee to facilitate the **Cass County Community Health Needs Assessment**
- Hosted "Safe Sleep 201: Helping Families Practice Safe Sleep" Training
- Hosted first annual Cass County Community Resources Forum
- Executive Leadership Team for the **Southwest Michigan Perinatal Quality Improvement Collaborative**
 - Quality Improvement Effort: Increase referrals to and enrollment in home visiting programs for pregnant women
 - Hosted regional "Quality Improvement (PDSA Model)" training
- Enhanced & Implemented a Safe Summer weekly summer campaign series
- Hepatitis A prevention at county fairs, increasing the number of handwashing stations
- Hosted four "Back to School" health events
- Began a **partnership with Van Buren Tech Marketing Program**; incorporating student involvement in the development of health promotion campaigns
- In partnership with Bronson Healthcare group, started a **policy, system, and environment** (PSE) assessment focused on uncovering opportunities for change related to nutrition and physical activity across Van Buren County (to be continued through 2020)
